

# HLM Footy Finals Promotion 2024

## Terms and Conditions

<b>Promoter</b>	CUB Pty Ltd (ABN 76 004 056 106), 58 Queens Bridge Street, Southbank VIC 3006.
<b>Who can enter?</b>	Only Australian residents; (a) aged 18 years or over; and (b) able to take the major prize between 28/09/2024 & 29/09/2024 in Melbourne.
<b>Who can't enter?</b>	Directors, officers, management and employees (and their immediate families) of: (a) the Promoter; and (b) the agencies, companies or participating premises associated with this competition.
<b>Competition Period</b>	12.01am (AEST) 29/07/2024 to 11.59pm (AEST) 01/09/2024.
<b>Venue</b>	The competition will run in four participating HLM liquor licensed venues in Victoria, where advertising is displayed.
<b>Qualifying Purchase</b>	2 pints (in one transaction, to share with a friend) of Carlton Draught.
<b>Entry instructions</b>	To enter, you must, during the Competition Period: (a) make a Qualifying Purchase from the Venue to receive an entry form from that Venue (subject to stocks remaining); and (b) fully complete the entry form and put it in the entry box at that Venue to receive an entry into the minor prize draw for that Venue and 1 entry into the major prize draw.
<b>How many winners will there be and how will they be chosen?</b>	There will be 5 winners determined in respect of this competition (1 minor prize winner for each Venue and 1 major prize winner). <b>Minor prize draws</b> There will be 4 minor draws conducted; 1 minor draw for each Venue. The minor prize draws will be held at 12pm (AEST) on 03/09/2024 in each Venue. In each minor draw, the first valid entry drawn randomly from the entries received during the Competition Period (in the Venue) will win the minor prize. Once all of the minor draws have been conducted, the entries from all Venues will be combined for the major prize draw. <b>Major prize draw</b> The major prize draw will be held at 6pm (AEST) on 06/09/2024 at Hotel & Leisure Management, 65 Flinders Lane, Melbourne, VIC 3000. ### Entry

- 1 Your entry must be received during the Competition Period and will be deemed to be received only when received by the Promoter. Entry forms from any other competition cannot be used for this competition, and are void if copied, forged, stolen or interfered with. Where relevant, submitted entry forms are the Promoter's property. If you return a Qualifying Purchase your entry may be deemed invalid at the Promoter's discretion (unless the product is defective). If you enter using automatically generated entries or multiple phone numbers/email addresses/addresses/aliases, you may be disqualified.

### Prizes

- 2 Prizes and all elements of prizes must be taken as specified, as and when offered and cannot be altered or changed in any way by you or will be forfeited, and if forfeited, the Promoter will not be liable. ### General

  - (b) engage in any conduct that may jeopardise the fair and proper conduct of the competition;
  - (c) act in a disruptive, annoying, threatening, abusive or harassing manner;
  - (d) do anything that may diminish the good name or reputation of the Promoter or any of its related entities or of the agencies or companies associated with this competition;
  - (e) breach any law; or

- 13 If companion/s can take the prize with you, you are responsible for your companion/s and the Promoter may disqualify all entries from, and prohibit further participation in this competition by, you or any or all of your companion/s if they materially breach these conditions, whether or not legally bound by them.
- 14 If you (or your companion/s, if applicable), in the reasonable opinion of the Promoter (and/or a medical professional, as relevant to the circumstances), are intoxicated, under the influence of alcohol or any other drug, behave aggressively or offensively, or behave in a manner which may diminish the good name or reputation of the Promoter or any of its related entities or the agencies or companies associated with this competition, is contrary to law or is otherwise inappropriate, the Promoter may cancel the prize or restrict you (and your companion/s) from participating in any elements of the prize, at its discretion.

- 16 If any dispute arises between you and the Promoter concerning the conduct of this promotion or claiming a prize, the Promoter will take reasonable steps to consider your point of view, taking into account any facts or evidence you put forward, and to respond to it fairly within a reasonable time. In all other respects, the Promoter's decision in connection with all aspects of this competition is final.

Without limiting any other term of these Terms and Conditions, all prizes (and elements of prizes) must be taken as and when specified, or will be forfeited with no replacement. not responsible for any change in prize value. You agree that if a prize (or element of a prize) is unavailable for any reason the Promoter may provide another item of equal or higher value, subject to any necessary approval by the state/territory gaming authorities.

- 18 If publication will take place, by entering, you request that your full address not be published.
- 19 If this competition cannot run as planned for any reason beyond the Promoter's control, for example due to software, hardware or communications issues, unauthorised intervention, tampering, fraud or technical failure, government directives, a pandemic, public health orders and the like, the Promoter may end, change, suspend or cancel the competition or disqualify affected entries/entrants, subject to any necessary approval by the state/territory gaming authorities.
- 20 The Promoter is not responsible for any tax implications arising from you winning a prize. You should seek independent financial advice. - 22 Subject to the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable (including in negligence) for any loss (including indirect, special or consequential loss or loss of profits), expense, damage, personal injury (including allergies, skin conditions or other reactions, as relevant), illness or death suffered in connection with this competition or any prize, except for any liability which under statute cannot be excluded (in which case that liability is limited to the greatest extent allowed by law).
- 23 Without limiting the previous paragraph, the Promoter and the agencies and companies associated with this competition are not liable for any loss of, damage to or delay in delivery of prize/s, or for any damage that occurs to displayed prize/s (where relevant) due to circumstances beyond the Promoter's reasonable control. Unless otherwise specified, prize/s will only be delivered to addresses in Australia.
